Sir,

This has reference to your letter No. MM/BGIMS/2010-480, dated 7th August, 2010, requesting permission for New Recognition to enroll the students for the Ph.D. (Arts) degree in the subject of Management Studies.

In this connection, I write to inform you that the report of the Local Inquiry Committee for New Recognition to enroll students for the Ph.D. (Arts) degree in the subject of Management Studies was placed before Board of University Teaching and Research (B.U.T.R.) in the Faculty of Arts at its meeting held on 2nd May, 2012 vide item No- 23 when it was resolved as under:-

Resolved that the report of the Local Inquiry Committee be accepted and that in accordance therewith, it be recommended to the Academic Council Maratha Mandir's Babasaheb Gawde Institute of Management Studies, Maratha Mandir Annexe, Balasaheb Gawde Chowk, Mumbai Central, Mumbai – 400 008, be granted for permission for New Recognition to enroll 4 (Four) students for the Ph.D. (Arts) degree in the subject of Management Studies for the period of five years from the academic year 2010-11 subject to the following condition to the satisfaction to the Academic Council:-

- a) Additional expenditure, equipment, laboratory space, journals, safety measures etc. should be specified clearly.
- b) For the Institute the vacancies for the enrollment/ registration of the student shall be advertised and 50% of the students enrolled / registered shall be graduates of the University of Mumbai who are not employee of the Institute. The admissions to these shall be granted on the recommendation to the University of Mumbai.
- c) The facility at the Institute / Center shall be made available to the other students of the University of Mumbai.
- d) The Institute / Center shall provide stipend to the students enrolled / registered.
- e) The Institute / Center shall provide one month 6th summer training to post graduates students of the University of Mumbai.
- f) The recognized teachers of the Institute / Center shall contribute in Post graduate teaching program of the University of Mumbai and make their services available for conduction of University examinations whenever required.
- g) The Institute shall make a yearly report on the work done for the information of BUTR, Academic Council and Management Council.

The above recommendations were accepted in Academic Council at its meeting held on 6th June 2012, vide item no 6.6.
